



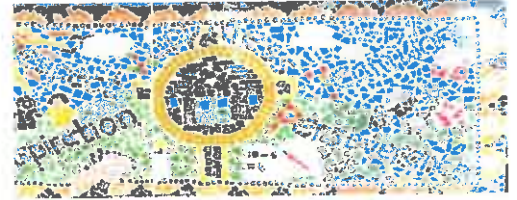

Dear Parent/Carer

TO: YEARS RECEPTION – YEAR 6: PUPIL PREMIUM / UNIVERSAL INFANT FREE SCHOOL MEALS

Although children in Reception, Year 1 or Year 2 will be benefiting from a 'universal free school meal', your school and child may also benefit from additional funding from central government known as Pupil Premium Grant. The government has introduced the Pupil Premium to help children from low income families reach their full potential and to achieve higher academic grades at school. The level of funding that the school will receive for 2018/2019 is £1320 for each child that is registered as meeting the statutory free school meal criteria.

In order to determine if your child qualifies and to allow us to claim the funding, we ask that all parents and carers of children in Reception, Year 1 and Year 2, who feel they meet the criteria below complete the attached form and return to The Welfare Team, Harrogate, as indicated on the form. If you have a child in Years 3-6 and you feel that you meet this criteria please complete the attached form and contact the school office or Headteacher in confidence to enable us to process your application. The attached form should be completed for all pupils who may be eligible.

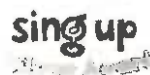
- Universal Credit, (provided you have an annual net earned income of no more than £7,400, as assessed by earnings from up to three of your most recent assessment periods)
- Income Support
- Income-Based Jobseekers' Allowance
- Income-Related Employment and Support Allowance
- Child Tax Credit, provided you are also not entitled to Working Tax Credit, and have an annual household income (as assessed by HM Revenue & Customs) that does not exceed £16,190
- Support under part VI of the Immigration and Asylum Act 1999
- Guarantee element of State Pension Credit
- A "Run-on" of Working Tax Credit - the payment someone may receive for a further four weeks after they stop qualifying for Working Tax Credit

The information provided on the form will be used by the council to check for eligibility to claim additional funding for the school (the 'pupil premium') from central government. Data may be shared with school and other areas across the County Council for administrative or other service provision purposes
