### **SAFEGUARDING - Online Safety:**

This week it was brought to my attention that some unkind messages were being written online from pupils at our school. It was also brought to my attention that children had been in videos on Tik-Tok posing in their underwear and in their school uniform from the school toilets.



#### **ZIP IT**

Keep your personal stuff private and think about what you say and do online.



#### **BLOCK IT**

Block people who send nasty messages and don't open unknown links and attachments.



#### **FLAG IT**

Flag up with someone you trust if anything upsets you or if someone asks to meet you offline.

Please can I remind everyone that mobile phones are not allowed in school. If they are required for personal reasons, this must be agreed with me and they must be handed in to the office first thing, stored in the school office all day and collected by the child at the end of the day.

Often we worry about strangers online but we must also educate children about the world they now live in and the interactions they have. The rise of the internet has created amazing opportunities to learn and explore the world around them. But it's also given bullies a powerful new platform to target children. Parents generally think the best advice is to just ignore bullies as in the old 'sticks and stones' rhyme. However, as cyberbullies aren't restricted to the school playground, and with the multiple internet-enabled devices and plethora of Social Media that children access nowadays, cyberbullies have 24-hour access to torment and abuse them.

It is my job to keep our children safe, so I spent some time in Class 3 and Class 4 discussing the impact of writing unkind messages on social media. If you haven't seen the campaign video, search for 'Internet Matters: Sticks and Stones' and you should be able to see it.



We have had many meetings with Mrs Clayton, hoping to encourage her to be part of the on site team but the decision was taken by her to remain in her current role. We wish her every luck moving forward as she remains an important part of our school team for breakfast club and lunch time.

We have had open and honest discussions over a period of many weeks - she fully understands and supports the fact that school has an obligation to provide a service for other families and that the children who currently use her service will continue to do so, and she has been involved in discussions explaining the reasoning around pricing. Again, please can explain that this is something new and may have to be tweaked - the aim is for this service to be cost neutral over time, considering natural fluctuations in attendance.
